1 Plaintiffs Mark Pacana, Paul Fiskratti, and Wayne Lewald (collectively, “Plaintiffs”) and
2 Defendant TTE Technology Inc. dba TCL North America (“TCL”), by and through their
3 respective counsel of record, hereby stipulate and agree to the following, subject to Court
4 approval:

5 WHEREAS, on July 8, 2022, the Court entered an Order “Preliminarily Approving Class
6 Settlement” (the “Order”) (Doc. 140);

7 WHEREAS, per the Order, class settlement notice began on August 8, 2022, claims were
8 due on October 7, and the Motion for Final Approval is due on November 20, 2022 (Doc. 140, p.
9 9);

10 WHEREAS, the parties believe that the claims period can remain open for an additional 30
11 days without prejudicing other Order deadlines, providing class members a total of 90 days to
12 submit a claim for settlement benefits; and

13 WHEREAS, the parties agree that this additional time for class members to submit a claim
14 is a benefit to the class;

15 THEREFORE, the parties wish to extend the claim deadline 30 additional days, from
16 October 7, 2022 to November 7, 2022.
